#### 5. Reason/s Why the bid was rejected/declared unsuccessful

#### a. BaseCamp IT Solutions

- i. Only offering OMR Software and not E-Marking Software.
- ii. During the demonstration, the bidder was not able to display the offered OMR and E-Marking Software.
- iii. Does not have contractual experience w.r.t. nature and financial requirements.
- iv. Not offering services for 18 months

#### b. Kenhar Enterprises

- i. Does not have required contractual experience of 02 similar projects w.r.t. nature and financial requirements.
- ii. Offered Software REMARK is only for OMR scanning and does not have E-Marking features.
- During the demo, the bidder mentioned that the source code of the software could not be provided.

### c. Analytical Solution Private Limited JV with Red Marker

- i. The bidder mentioned forming JV with Red Marker for lot-B, during the opening of bids but no such agreement was found in the submitted Bids. Instead, three letters of intent are found (Allied Testing, Red Marker and Social Economic Consultant) but the ELI-I forms of Red Marker and Social Economic Consultant are not found attached.
- ii. JV agreement submitted for lot-A with Allied testing services mentioned to provide OMR Software which is part of Lot-B.
- iii. The bidder failed to show having the similar contractual experience as required in bidding document w.r.t. similar nature. Some Contract agreement are attached of Allied Testing Services (which is not part of JV for this lot-B) which are about conducting tests for certain positions.
- The offered Software REMARK is only for OMR scanning and does not have E-Marking features.
- v. During the demonstration, Red Marker was present, but JV was not able to show the OMR and E-Marking Software which they claimed to offer.
