1. Objective and Scope:

The Government of Sindh (GOS) has received a loan from Asian Development Bank (ADB) for Sindh Secondary Education Improvement Project – Additional Financing (SSEIP-AF). Part of the additional financing will be used for consultancy services of SELD/SSEIP/Cons-02: Package-2: Design Review and Milestone Based Top Construction Supervision Consulting Firm, to provide Milestone Based Construction Supervision Services for 361 schools in nine (09) tehsils Talukas [(i) Bhirya; (ii) Dadu; (iii) Kambar; (iv) Kandiaro; (v) Larkana; (vi) Mehrabpur; (vii) Moro; (viii) Naseerabad; and (ix) Naushero Feroze]] of (i) District Dadu; (ii) District Kambar-Shahdadkot; (iii) District Larkana; and (iv) District Naushero Feroze in Sindh Province, Pakistan.

2. The School Education and Literacy Department will be the Executing Agency (EA) while Project Implementation Unit (PIU), SSEIP will be the Implementation Agency (IA). The PIU has already been established which will act as a project owner and will provide guidance on, and oversight to, the overall implementation and performance of the project.

3. PIU, SSEIP-SELD, GOS is now seeking Expressions of Interest (EOI) from reputable national firms and/or in association with other national / international firms to carry out the Design Review and Milestone Based Top Construction Supervision consultancy services.

4. Consultancy Services:

The consultant teams will be headed by a Team Leader and composed of national experts; the required expert input is tentatively mentioned in the following table.


