Part of this financing will be used for payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The School Education and Literacy Department, Government of Sindh ("the Employer") through Project Director ("the Employer Representative"), Project Implementation Unit (PIU), Sindh Secondary Education Improvement Project (SSEIP), School Education and Literacy Department, Government of Sindh (GoS) invites sealed bids from eligible Bidders for the construction and completion of Lot / Lots as mentioned above ("the Works"). Bidders may submit separate bid for one or multiple Lots. However, a Bidder may be awarded one or multiple lots if it submits the lowest evaluated substantially responsive bid(s) provided such bidder meets the aggregated qualification requirements for one lot or such multiple lots.
- 3. Open competitive bidding National advertisement will be conducted in accordance with the ADB's Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
