- In case a public holiday is announced by the Government (Due to any reason) the deadline will be considered next working day at the same time and venue.
- Rates must be inclusive of all types of taxes and any other associated costs. Service Sales Tax should be clearly mentioned separately, if applicable. If the bidder is registered in a tax-exempted area, supporting document must be provided.
- Bidders are required to submit a bid security equivalent to 3% of the bid value in the form of a CDR Pay Order in favor of "Muslim Aid". Bids without the bid security shall be rejected. The bid security must be included in the financial proposal.
